The Workshop cum awareness program was conducted at Bihari Lal Inter College, Dhankaur by Legal Aid Clinic of Galgotias University, School of Law on 13th November 2021 from 11 am to 2 00 pm. It was an effort to celebrate PAN India legal awareness and outreach campaign initiated by NALSA under Azadi ka Amrit Mahotsav.

It came out as a very successful event led by School of Law's finest faculty Dr. Narendra Bahadur Singh, Dr. Niteesh Kumar Upadhyay and Mr. Deepak Kaushik. The aim of the Workshop was to make children aware of the basic rights related to filing of an FIR and process of Arrest. Besides this the rights of women in domestic arena were specially focused upon.

Event was started by Dr. Narender Singh where he greeted all the students, teachers and the respected Principal. The message was sent across as to how important it is in today's world to know basic rights. After the brief Introduction Dr Nitesh Kumar described Workings of Legal Aid and its importance specially in context of Human Rights. To support the idea more than 100 flyers were distributed to faculty members and students along with UDHR brief booklet on Human Rights.

Following it was a Nukkad Natak was by Legal Aid Members led by Pankaj Shukla, (Convener Legal Awareness Cell) portraying the evil custom of Dowry in our social set up. It was very expressive and illustrative of harsh reality of Dowry and social degradation regarding the same. The Natak questioned various beliefs and inspired students to question the morals of the system around.

Mr. Deepak Kaushik took the lead further and explained the the rights related FIR and Arrest in simple terms but still informational enough to help students grasp sublimely. Workshop was concluded by Pranshi Agarwal, member of Legal Aid clinic giving an overview of rights after arrest.

In the end there was a vote of thanks by the school authorities and a small token appreciation was given to all legal aid members and the faculty. Overall Event was a huge success. Students of the school were very bright and participative enough to welcome the efforts of our team..
