

EQUIPMENT DONATION AGREEMENT

This Equipment Donation Agreement (the "Agreement") is made by and between **MSPARK FUTURISTICS & ASSOCIATES ("Donor")** and **GALGOTIAS UNIVERSITY**.



1. **The Equipment.** Subject to the terms and conditions of this agreement, the Donor transfers all rights, titles, and ownership of the equipment described in the attached Schedule **A** (the "Equipment") to the Department of Civil Engineering (Galgotias University) for the use and enjoyment of Galgotias University. The title to the Equipment will vest in the Department of Civil Engineering (Galgotias University) upon the Equipment's arrival at the Department of Civil Engineering (Galgotias University) campus. Promptly upon receipt of Equipment by Galgotias University, the Donor will provide any and all documents necessary to record the transfer of title in the Equipment. The transfer does not include or convey any license, title, or other rights in any patents, trademarks, copyrights, know-how or other intellectual property of any kind.
2. **No Payment.** Donor and Department of Civil Engineering (Galgotias University) agree that each party's performance of this agreement constitutes full consideration and that the Department of Civil Engineering (Galgotias University) is not obligated to pay for the Equipment.
3. **Use of Equipment.** Department of Civil Engineering (Galgotias University) may use the Equipment for any purpose it deems appropriate and there is no expectation of reversion of the Equipment to Donor under any circumstances whatsoever.
4. **Warranties.** Donor warrants that:
 - a. The Equipment is safe and suitable for use by the Department of Civil Engineering (Galgotias University) and has no known dangerous defects; and,
 - b. There are no claims, judgments, liens, or other encumbrances of any kind whatsoever against or upon the title to the Equipment; and,
 - c. No customs laws, tax laws, or other laws or regulations applicable to the Equipment or its export or import, have been broken.






