and

Galgotias University, India

Anglia Ruskin University (ARU) and Galgotias University (GU) share a commitment to the provision of high quality education. Both recognise the value of the international dimension of their activities and the mutual development of research, teaching and quality assurance activities.

Our two institutions agree to commit the necessary staff time and resource to develop partnership arrangements including but not limited to:

- Offering students who have completed years 1-3 of the 4 year BTech Civil engineering programme at Galgotias University the opportunity to progress to year 3 of the BEng Civil Engineering at Anglia Ruskin University in the UK;
Exploring opportunities for ARU to provide training and development courses for teachers from GU;
Exploring opportunities for staff and student visits, including a summer programme in the UK for interested students from GU.

A liaison group will be constituted between our two institutions, which will have the responsibility to lead these developments and to maintain appropriate communication through visits and regular contacts.

This Memorandum of Understanding establishes the commitment of both GU and ARU to pursue the development of closer academic links. It is therefore agreed that neither institution wishes to be legally bound by the Memorandum but may enter into formal contractual arrangements in the future. This Memorandum implies no financial obligation on either institution.
