MEMORANDUM OF UNDERSTANDING

First Party (CETPA Infotech) Deliverables:

A First Party would conduct Training on JAVA SE8 Programming cum Oracle 12C, and PLC-SCADA for the students of Second Party.

- B. First Party will deliver the training at Second Party campus.
- C. First party will provide following course material:
 - E-Books
 - Hard copy of handouts
- D. After completion of the training, students can appear for the international certifications in related domains.
- E. The students shall be registered with CETPA Infotech Pvt. Ltd. Certificates of Completion will be provided to the participants after successful completion of the respective course.
- F. CETPA 1 Year Membership Card will be provided to all the participants so that they can attend revision classes in CETPA in the registered training course.
- G. Minimum Batch Size will be of 50 Students.
- H. First Party will provide the Certificates of honour to best trainees in each batch.

Second Party (Galgotias University) Deliverables:

- A. Second Party will provide minimum 50 students.

- **E.** Second Party will ensure for co-coordinators for disciplinary activities.

- The MOU would be valid for 1 Year on mutually agreeable terms. The MOU can be renewed
 after 1 year subject to imparting satisfactory training deliverables by CETPA INFOTECH PVT
 LTD.
- Timing of the class will be decided after proper discussion with University Administration.
- Both the Parties will appoint one Single Point of Contact (SPOC) for smooth functioning of the training program.

University will provide the payment to CETPA as follows:

- a. 25% of the Payment along with Work Order before the starting of the training program will be paid to CETPA.
