Whereas the university is an educational institution providing B.Sc. Degree program in Nursing approved by Indian Nursing Council (INC) & Uttar Pradesh State Medical Faculty.

Whereas clinical Education/Training/Activities in the Nursing care of individuals, families and groups is required as an integral part of B.Sc. Nursing program as per INC.

Whereas the GIMS, Grater Noida possesses the facilities and professional expertise to provide clinical education/training to the University Students enrolled in its Nursing Degree program.

NOW THEREFORE, the following are the complete terms and conditions that the parties intend to be legally bound for affiliation of, GIMS, Greater Noida to provide clinical education & training to students of Galgotias School of Nursing:

Duties and Responsibilities of the University

- Administration of Program: The University shall assume responsibility for the administration of I. the clinical program, including, but not limited to, curriculum development, grading, requirements for schooling and clinical hours as per regulatory body of Nursing i.e., INC.
- Supervision of Students' Clinical Practice: The University shall designate its own faculty qualified by training and experience to plan, oversee, and evaluate the students' clinical practice activities. The faculty-student ratio of 1:10 be maintained throughout the session. It will be the duty of supervisory teacher that students will follow the instructions of the duty doctors and will not do anything which is not ordered to them.
 - Dissemination of Information: The University shall inform all students and faculty of their responsibilities under this agreement including their obligation to abide by the rules and regulations of the
 - Number of Students: The University shall provide the GIMS, Greater Noida with the number of Site. students to be mutually agreed upon for the days and hours mutually agreed upon as per the regulatory body which will be informed prior to their posting.
 - Health Status: The University shall require students participating in the clinical program to meet the health requirements of the hospital and/or Indian Nursing Council/ state Nursing Council. Proof of compliance may be required before participation in the program.
 - Transportation: Students shall be responsible for their own transportation to and from placement
 - Notification: The University shall notify the GIMS, Greater Noida of any changes in faculty, sites. curriculum, and policy that may affect the clinical education program as per INC guidelines. (APPENDIX II) Syllabus, curriculum, clinical hours of posting and rotation.
 - H. University shall provide the amount Rs. 2,500/student/year basis to the institute's fund which will be utilized for the patient care as well as to improve the training facilities for the nursing students in the facility. University shall also help GIMS, Greater Noida to develop a "Skill Lab" for explaining & assessing the procedure learnt by their nursing students in a better way instead of experimenting on real patients.

II. O Duties and Responsibilities of the GIMS, Greater Noida

Structure of the Clinical Program: Institute will only provide clinical training to all the all candidates of nursing program during their clinical posting. The GIMS, Greater Noida shall provide facilities. nursing practice, verify and issue clinical posting completion to all our university students. Virendra Kr. Garg Ad.

B. Liaison/Field Coordinator: The GIMS, Greater Noida shall designate a permanent employee to serve as liaison/field coordinator between the Hospital and the University.

- Orientation: The GIMS, Greater Noida shall orient the faculty and students to the rules, regulations, and practices of the facility and shall also provide necessary regulatory and safety compliance during training.
- Patient Care Responsibility: The GIMS, Greater Noida shall retain full responsibility for the supervision and care of all patients admitted there.
- E. Reservation of Rights: The GIMS, Greater Noida reserve the right to reasonably discipline any student or faculty member of Galgotias University, who fails to comply with facility policies and procedures. Discipline may result from conduct, work, or health status that materially interferes with the Institutions' ability to care for patients or impairs the student from benefiting from the clinical experience. The Institute shall notify the University's faculty member responsible for the student practice or the appropriate Assistant Dean or Dean in case of supervising faculty.

III. Mutual Terms and Conditions

- **Duration of Agreement**: This agreement shall commence with the beginning of the month July A. 2021 till July 2022 and will be cancelled if not renewed or at another mutually agreeable date, and shall be considered renewed from academic year to academic year unless either party seeks to terminate this agreement.
- Termination of Agreement: The University and/or the GIMS, Greater Noida may terminate this agreement, for any reason, by giving the other party written notice thirty (30) days prior to the effective date thereof.
- Modification of Agreement: All modifications, waivers or alterations to this agreement must be approved in writing by both parties.
- D. Relationship of Parties: The University and GIMS, Greater Noida shall be considered independent contractors to one another. This agreement shall not create a partnership, joint venture, or association between the University, any of its students, and the GIMS, Greater Noida.
- E. Entire Agreement: This agreement represents the complete understanding between the Galgotias University and the GIMS, Greater Noida. It shall supersede prior oral or written understandings and promises relating to this subject matter.
- Collaboration: This agreement shall be also treated as collaboration with Galgotias University and GIMS for giving Health Care services to Students and Staff of Galgotias University for any causality and all kind of treatment on emergency basis.
