
About Glass Academy Foundation

Context and Rationale of Memorandum of Understanding:

With the advent of technology and availability of materials locally, buildings in India have started having extensive amount of glazing – either in the form of façade glazing or in the form of windows. The private and Government infrastructure is also witnessing major growth in all parts of the country in which structural glazing plays a vital part of it.

However while the Glazing Industry has grown very fast, there are gaps in knowledge expertise and skills in appropriate selection, design, Processing and glass installation which has led to difference in need and suitability, inappropriate design, poor quality of workmanship, delayed completion and additional costs arising from rework. This requires a wide range of Knowledge and skills that are not yet been recognized as Subject of importance to be learnt, specific skill or trade.

Now, the parties herein have agreed to execute this Deed of Memorandum of Understanding on the following terms and conditions:

Article 1: Purpose

To provide the students of Architecture and Civil Engineering, a platform and opportunity to learn on the latest trends on Glass Architecture and Design and Glass Façade Engineering by providing them with an industry endorsed certification program cum elective course under their curriculum in association with Galgotias University, a renowned institution with rich experience in educating & serving the student fraternity and holds the experience of promoting many budding talents with various innovative programs.

This program shall offer students the concepts on Glass Architecture and Design and Glass Façade Engineering right from basics to the design considerations with case studies and examples along with expert advices and sessions to give them a clear insight on the operation of Building Envelopes in Architecture & Construction.

Article 2: Scope

1. The Glass Academy Foundation follows a systematic approach to the elective course & curriculum development. The course duration is for a semester based on the criteria of the participating institution.
2. This industry endorsed certification & value addition cum elective course shall be implemented in Galgotias University, Greater Noida.
3. This program shall be jointly certified by the Glass Academy Foundation and Galgotias University.

Article 3: Geographical area extended by the Agreement

This project shall be implemented at Galgotias University.

Article 4: Duration of the project and of the contractual Agreement

This Agreement shall be made for a period of five years from the date of execution of Agreement within which the activities mentioned in the Agreement are to be carried out. The parties may, after mutual consultation, extend the period of the Agreement as deemed necessary.

Article 5: Roles and responsibilities

- Galgotias University shall be responsible for:
 - Enrollment of appropriate students (stream, year of study, students enrolled under management of Academy of Architecture) under this elective who are bonafide students of the College under Architecture Stream
 - Providing a dedicated classroom/ conference hall with projector and internet facility to enable students take up the Expert sessions, eLearning & Webinars sessions (online lectures- Live & recorded)
- Galgotias University, shall nominate a trainer(s) & coordinator(s) for this program
- Galgotias University shall send the trainer(s) nominated for this course for a one-week Faculty Development Program organized by Glass Academy Foundation
- Galgotias University through the nominated coordinator, shall take responsibility in communication with Glass Academy Foundation in scheduling/ re-scheduling of the sessions, webinars, assessments and other necessary communications to the students.
- Galgotias University shall take responsibility for the logistics of the students during industrial visit, if any.

- Galgotias University, shall communicate the students regarding upcoming Webinars, schedule/ change in schedule, expert visits to colleges, Expert sessions, deadlines and regarding the assessment.
- Galgotias University shall keep close watch on the co-ordinator/ Representative to keep track on the activities regarding the program
- Galgotias University shall be responsible of the student enrollment in the elective. The certificate shall be issued to successful candidates only if the student is a bonafide candidate of Academy of Architecture.
- College undertakes to have a close monitoring of the project.

Glass Academy Foundation

- Glass Academy Foundation shall be the main facilitator for the implementation of the Project.
- Glass Academy Foundation shall be responsible for:
 - Course content & development
 - Syllabus of the course
 - Teaching Aid (Audio – Visuals)
 - Cloud campus Video curriculum- Online Pre- recorded Classroom learning
 - e- Learning Latest generation animated LMS (version #5.1) modules with voice over and transcript
- Glass Academy Foundation shall take responsibility of training and re-training of the nominated trainers for the coordination of this elective course.
- Glass Academy Foundation shall coordinate with the industry experts and invite them for the faculty development program.
- Glass Academy Foundation shall take care of the logistics & accommodation of the industry experts during the training period.
- Glass Academy Foundation shall take responsibility of the scheduling & sourcing of experts for sessions during the Faculty development Program.
- Glass Academy Foundation shall take responsibility for arranging the industry visits to Architecture firms, Glass processing and fabrication lines and receive the necessary approvals and permissions for the same.
- Glass Academy Foundation shall provide students with login credentials for the Glass Academy Foundation e-Learning portal to access the animated modules, cloud classroom modules & webinars.
- Glass Academy Foundation takes responsibility in hosting & maintenance of Server (Learning Management System), Learner Access, Curriculum assignment, subscription license, MIS reports and online assessments.

- Glass Academy Foundation shall have the copy right for all the teaching materials, learner guide, faculty guide, etc; used for the purpose of all the courses in Glass Academy Foundation other than any of the material in existence, use and in ownership of Galgotias Univeristy prior to the commencement of curriculum committee activities. Glass Academy Foundation reserves the right of reproduction or use in any form in any part of the world of any of these documents and materials, as it deems fit.
- Glass Academy Foundation reviews the project monthly.
- Glass Academy Foundation undertakes to have a close monitoring of the project.

Article 6: Publicity

- Glass Academy Foundation and Galgotias University shall publicize in any manner whatsoever any work executed by it under this agreement with the prior written communication of both the parties.
- Glass Academy Foundation and Galgotias University shall use their Logo or any brand names/trademarks in any publicity material with the prior written communication of both the parties.

Article 7: Confidentiality

During the term of this Agreement, certain Confidential Information shall be disclosed by one Party to the other. The Parties acknowledge the confidential nature of any proprietary and other information and documentation, whether in written, printed or oral or other form, furnished or made available by one Party to the other Party pursuant to or under this Agreement ("Confidential Information"). It is agreed that the Confidential Information will be kept in strict confidence and will not be used by a recipient Party except to the extent necessary to act strictly in accordance with this Agreement and, if the Confidential Information is in the form of documents or data, the recipient Party will return it to the disclosing Party upon the expiration or termination of this Agreement.

Article 8: Financial Terms

There shall be no financial implications for this project for both parties
