# CYBER SECURITY PROGRAM

#### TÜV SÜD - SCOPE OF WORK

#### Phase 1

- Development of student internship program on Cyber security subject for B.Tech 4<sup>th</sup> & 6<sup>th</sup> semester
  of 100 Hours which includes classroom training, group assignment & project, industrial visit,
  examination & certification.
- Development of Master Trainer Program (Train the trainer) on Cyber Security subject for the faculties of Galgotias University. Trainers will be evaluated and certified by TUV SUD as certified trainers.
- 3. Development of Job Role based Advance Modules which will be offered to students in Year 3 and Year 4
- 4. Provide internship platform within TUV SUD Group and its clients where ever possible.
- 5. Development of detailed syllabus and its vetting by a cross-functional team; representatives from TÜV SÜD South Asia, University, and Industry.
- 6. Conducting Faculty Development Program in the subject of Cyber Security to enable Galgotias to remain self-sufficient to run this programs.
- 7. A joint certificate with Logo of TUV SUD South Asia's and Galgotias University would be issued by TUV SUD South Asia to all participants.

#### Phase 2:

- 8. Development of Two Years Program in Cyber Security which will get integrated with first two years of Engineering curriculum (4 years' degree program)
- 9. Detailed induction to University's computer science / information technology faculty in order to review the course outline and exchange the know-how in developing syllabus.
- 10. TUV SUD Personal Certification Cell to perform regular assessment, examination and certification of the students for both Basic and Advanced Modules.
- 11. Development of classroom training and e-Learning content for all the modules including exam, rules, certificate template.
- 12. Will provide advisory support in setting up Cyber Security Lab in the University.
- 13. TUV SUD would be authorized to audit any time the material, delivery and feedback of the courses which are delivered by certified faculties of Galgotias University.

# Galgotias University - SCOPE OF WORK

- 1. This Memorandum of Understanding is specific to students enrolled directly with Galgotias University.
- 2. Galgotias University would ensure minimum student enrolments to any program executed by TUV SUD to ensure the economic feasibility and success of the program.
- 3. Galgotias University would give in writing to TÜV SÜD one month before the commencement of the program, the number of students with their application forms, who would undergo the training and

- 4. Galgotias University would nominate one person who would be a single point of Contact with TÜV SÜD for all Administrative purposes.
- 5. Galgotias University Would Monitor the attendance of the students and share the same with TÜV SÜD for certification purpose.
- 6. 80% of attendance for the designated program would be mandatory as an eligibility to attend the examination and certification of TUV SUD.
- 7. Galgotias University would support with the infrastructure required for organizing workshops, Faculty Development program and Seminars.
- 8. Faculties who have attended the Train the Trainer Workshop and have been successfully certified by TUV SUD would further train the students of Galgotias University.
- 9. These Trained students of Galgotias University would be assessed by TUV SUD Personnel Certification cell and those who meet the passing standards would be provided a joint certificate from TUV SUD and Galgotias University.

#### **BASIC TERMS & CONDITIONS:**

#### 1. Students

List of students wanting to undertake the Training should be sent to Academy Division of TÜV SÜD one month in advance. The name of students mentioned in the list, shall be used for Certification purpose by TÜV SÜD.

#### **Attendance**

Attendance will be monitored by the project Coordinators of TÜV SÜD on a regular basis and will be utilized before issuing of certificates.

#### **Quotation and Payments**

All payments to TÜV SÜD would follow guidelines as mentioned below:

a. Galgotias University would make payment 50% in advance to initiate the programs and balance 50% will be paid after the completion of the program. Galgotias University will guarantee minimum of 60 students in a batch to start the internship training program.

# 4. Obligation to Maintain Secrecy, Copyright, Data Privacy & Protection

- a. TÜV SÜD shall be authorized to maintain record of written documents which have been made available to it for review and which are important for conducting the Training and examination.
- b. TÜV SÜD, its staff and any experts who may be called in, shall not disclose and use, trade and business matters of Galgotias University about which they have gained knowledge of during the performance of their work without proper authorization.
- c. Galgotias University and its students shall not re-produce, disclose or alter the content given to them for the purpose of training and examination. TÜV SÜD solely reserves the right for the same

- a. Certificates will be issued by TÜV SÜD to the successful students on receipt of full payment.
- b. Students who appear and clears a written test in the Pre-defined subject would be awarded <u>TÜV</u>
  <u>SÜD's Certified (Subject) Professional certificate.</u>

Relevant study materials, syllabus and learning objectives would be jointly developed by TUV SUD and Galgotias University for all modules. The Jointly developed material would be provided by Galgotias University to the students. TÜV SÜD however does not guarantee the printing quality of the study materials and TÜV SÜD shall not be held responsible for any non - handing over of study materials.

Any Change in the syllabus, training methodology should be subject to review and approval from TUV SUD and Galgotias University

<u>NOTICE:</u> Note all examination questions as prepared by TÜV SÜD SOUTH ASIA for the purposes of this MOU and are necessarily based on the contents of the study materials. Self-experience in the industry and education may also be the basis for some questions.

#### 7. Jurisdiction, and Applicable Law

This MOU shall be governed by India laws and courts in Mumbai alone shall have exclusive jurisdiction to try any suit arising out of this MOU.

#### 8. Use of the Certification of TÜV SÜD

- a. The use of the certification is limited to those students who have successfully completed the written tests and passing criteria will be decided mutually in advance.
- b. The use of the TÜV SÜD Certification shall not be used in promotion or advertising efforts.

#### 9. The TÜV SÜD Certification Program Amendments

Policy and Procedures, as contained herein, may be amended upon the recommendation of the TÜV SÜD Advisory Council with the approval of the TÜV SÜD Executive and Legal Committee and the



Certification Administrator.

#### 10. Commencement, Term & Renewal

This MOU shall remain valid for a period of two years from the date of execution of this MOU, unless terminated earlier.

# 11. Use of the name of TÜV SÜD SOUTH ASIA South Asia (P) Ltd

Galgotias University or any college/institutions or organizations associated with Galgotias University and the students would not be entitled to use TÜV SÜD logo in any form. However, Galgotias University can use the name of TÜV SÜD South Asia (P) Limited in whole in their brochures and catalogues only. In case of any breach of the same by any college/institutions or organizations associated with Galgotias University and the students, Galgotias University shall be responsible for the same.

#### 12. Representations and Warranties

The Parties represent and warrant to each other as follows:

- The execution and performance of this MOU does not conflict with other MOUs of the warranting Party and will not conflict with restrictions of governmental authorities including the applicable laws;
- b The execution and performance of this MOU is within the power of the warranting Party and have been duly authorized by the said Party;
- Galgotias University agrees to indemnify and keep indemnified TÜV SÜD and its successors against all claims, losses, liabilities, obligations, damages, deficiencies, judgments, actions, suits, proceedings, arbitrations, assessments, and reasonable costs and expenses (including without limitation, reasonable attorney's fees), arising out of any third party claims lodged against the TÜV SÜD SOUTH ASIA or TÜV SÜD has suffered any loss or damages by the statements, representations and assurance made by Galgotias University.

# 13 Confidentiality

ii.

The Parties will, at all times, maintain the utmost confidentiality regarding the contents of this MOU and any business, technical or financial information that is, at the time of disclosure, designated in writing as confidential (hereinafter the "Confidential Information"). None of the Parties will make any announcement to the public or to any third Party regarding the arrangements contemplated by without the consent of the other Party, provided such consent shall not be unreasonably withheld or delayed. Any statement or disclosure which may be required by law or called for, by the requirements of any regulatory authority and any such statement or disclosures shall be no more extensive than is usual or necessary to meet the requirements imposed upon the Party making such statement on disclosure.

- b. The receiving Party shall not be liable for disclosure or use of any Confidential Information if the same;
  - i. Is in or enters the public domain;
    - Is known to the receiving Party at the time of first receipt, or thereafter becomes known to the receiving Party prior to such disclosure without similar restrictions from a source other than the disclosing Party, as evidenced by written records;

- iii. Is disclosed pursuant to any law or order of any court or regulatory authority having jurisdiction over the receiving Party;
- c. The provisions of this Clause shall survive the termination of this MOU.

# 14. Termination & Consequences of Termination

- a In the event either party hereto commits a breach of any of its obligations under this MOU and/ or any other rules made applicable to Galgotias University hereto, the TÜV SÜD may terminate this MOU without giving the defaulting party any notice to remedy the default.
- b Either Party may terminate this MOU forthwith if the other Party becomes insolvent or bankrupt or makes an arrangement with its creditors or goes into liquidation.
- c Either party may terminate this MOU after giving the other party 30 (thirty) days' notice in writing.
- d Upon termination, all accounts shall be taken and settled between the parties within a period of 15 days from the date of termination
- e Termination of this MOU under this article will not prejudice any rights of either Party, which have arisen on or before the date of termination.

# 15. Intellectual Property Rights

- a. Galgotias University acknowledges all proprietary rights including any intellectual property right in the Material provided to the Galgotias University for the purpose of training and certification shall vest and continue to vest TÜV SÜD. Nothing in this Agreement or in any other document shall construe transfer of any intellectual property rights in favour of the Galgotias University
- b. Violations in any form by the Galgotias University shall lead to termination of this Agreement

# a. Notices

All notices, waivers and other communications required or permitted hereunder shall be in writing, in English language, and communicated to either party at the addresses stated above or such other address or addresses as any such Party may from time to time designate by written notice. All such notices may be given by personal delivery, Telefax or by courier mail.

Any natice, waiver or other communication shall be deemed to have been duly given:

On the expiry of 10 days after posting, if transmitted by registered mail;

On the date of delivery, if delivered personally or by courier:

On the date immediately after the date of transmission with confirmed answerback if transmitted by facsimile, whichever shall first occur?

# **Partial Invalidity**

If any provision of this MOU or the application thereof to any person or circumstance is or becomes invalid or unenforceable to any extent, the remainder of this MOU and the application of such provision to persons or circumstances other than those as to which it is held invalid or unenforceable, shall not be affected thereby, and each provision of this MOU shall be valid and enforceable to the fullest extent permitted by law.

#### **Amendments**

No modification or amendment to this MOU and no waiver of any of the terms or conditions hereof

shall be valid or binding unless made in writing by all Parties.

#### d. **Assignment**

Any party shall not assign the benefit of any of its rights and/or obligations under this MOU without the prior consent in writing of the other parties.

#### Relationship e.

Nothing in this MOU shall create, or constitute or be deemed to create or constitute a partnership or joint venture between the Parties or any of them, or between the Parties or any one of them nor constitute or create or be deemed to create or constitute a Party as an agent of any other Party/Parties for any purpose whatsoever. The relationship between the parties is strictly on a principal to principal basis and no Party shall have any authority or power whatsoever to bind or commit, act or represent or hold itself out as having authority to act as an agent of, or in any way bind or commit the other Party or Parties to any obligations. The rights, duties, obligations and liabilities of the Parties shall be several and not joint or collective, each Party being individually responsible only for its obligations as set forth in this MOU.

#### f. **General Compliance**

The Parties agree that they shall, in the performance of this MOU, comply with all legal and regulatory requirements as may be applicable from time to time.

#### Counterparts g.

This MOU shall be executed in any number of counterparts, all of which shall be deemed to be an original, but when taken together shall be one and the same MOU
