The Academic Council discussed the issue at length and approved to conduct the University Examination through online mode subject to:

- 1. Lawfulness, Fairness and Transparency
- 2. Infrastructure tenability of examiner and examinee
- 3. Accountability and Auditability
- 4. Hassle free
- 5. Any other precaution required
- 6. Guidelines of statutory bodies & State Govt. have proposed the same.

No other matter was discussed.

The Meeting ended with a vote of thanks to the Chairperson.
