**REGULATIONS FOR LATERAL ENTRY ADMISSIONS AND  
MIGRATION OF STUDENTS FROM OTHER  
UNIVERSITIES/COLLEGES BY  
TRANSFER OF CREDITS**

**(For the Year 2022-23)**

The policy is being introduced to provide an opportunity for higher studies to those candidates who have completed their diploma / degree / First year (for migration) with good record and to provide more professional manpower by filling up the vacant seats from first year of various programs.

Galgotias University is accepting the student's applications under the lateral entry/migration scheme for various Undergraduate and Diploma programmes for the academic year. Candidates who fulfil the eligibility conditions shall be given opportunities at Galgotias University for professional growth and career improvement, through lateral entry / migration into courses of general, technical and professional education.

**LATERAL ENTRY (For Admission to Undergraduate Programmes)**

Candidates who have acquired a Diploma from recognised institutions in Engineering / Allied health / Pharmacy / Hotel Management / Design or Architecture or any other relevant field with not less than 50% marks in aggregate or its equivalent, through minimum of 2 years after 10+2 or 3 years after class 10, shall be eligible for admission in the second year / third semester of concerned UG program as per eligibility.

**Candidates seeking admission in the second year/ third semester of undergraduate programmes should have:**

**For B.Tech programmes**

For being eligible to seek lateral entry to Engineering degree programmes at the 2<sup>nd</sup> year/3<sup>rd</sup> Semester, a candidate must have Passed Diploma examination with at least 50% marks or its equivalent in any branch of Engineering and Technology from recognized institute.

OR



For being eligible to seek lateral entry to an Engineering degree programme at the 2<sup>nd</sup> year/3<sup>rd</sup> semester, a candidate must have Passed B.Sc. Degree from a recognized University with at least 50% marks or its equivalent and passed 10+2 examination with Mathematics as a subject from recognized institute.

### **For B.Pharm Program**

For being eligible to seek lateral entry to Bachelor of Pharmacy (B.Pharm) degree programme at the 2<sup>nd</sup> year/3<sup>rd</sup> semester, a candidate must have Passed Diploma in Pharmacy (D.Pharm) with minimum 60% marks or its equivalent from recognized institute.

### **For BPT Program**

For being eligible to seek lateral entry to Bachelor of Physiotherapy (BPT) degree programme at the 2<sup>nd</sup> year/3<sup>rd</sup> semester, a candidate must have Passed Diploma in Physiotherapy with minimum 50% marks or its equivalent from recognized institute.

### **For B.Optomtry Program**

For being eligible to seek lateral entry to Bachelor of Optometry degree programme at the 2<sup>nd</sup> year/3<sup>rd</sup> semester, a candidate must have Passed Diploma in Optometry or Ophthalmic technician with minimum 50% marks or its equivalent from recognized institute.

### **For B.Sc MLT Program**

For being eligible to seek lateral entry to B.Sc Medical Lab Technology degree programme at the 2<sup>nd</sup> year/3<sup>rd</sup> semester, a candidate must have Passed Diploma in Medical Lab Technology or Pharmacy with minimum 50% marks or its equivalent from recognized institute.

### **For B.Des Interior Design Program**

For being eligible to seek lateral entry to Bachelor of Design (Interior Design) degree programme at the 2<sup>nd</sup> year/3<sup>rd</sup> semester, a candidate must have Passed Diploma in Interior Design or Architectural Assistanceship with minimum 50% marks or its equivalent from recognized institute.

### **For B.Sc Hotel Management or Bachelor of Hotel Management**

For being eligible to seek lateral entry to B.Sc Hotel Management or Bachelor of Hotel Management degree programme at the 2<sup>nd</sup> year/3<sup>rd</sup> semester, a candidate must have Passed Diploma in Hotel Management with minimum 50% marks or its equivalent from recognized institute.



## LATERAL ENTRY (For Admission to Diploma Programmes)

Candidates who have passed 10+2 with any 3 of Physics/Chemistry/Mathematics/Biology/Computer Science/Electronics/Information Technology/Informatics Practices/Biotechnology/Technical Vocational subject/Agriculture/Engineering Graphics/Business studies/Entrepreneurship

### General Guidelines:

- a) The selection of candidates will be based on the merit.
- b) Bridge courses may be prescribed in order to make up deficiencies, if any, who are admitted through lateral entry for which a fee may be charged.
- c) The lateral entry will be allowed only in 2<sup>nd</sup> year/3<sup>rd</sup> semester.
- d) Admission through lateral entry shall be allowed within the limit of 10% of the sanctioned intake of a programme.
- e) Admission, if granted, would remain provisional till all document verification process is complete.

### 1. MIGRATION OF STUDENTS FROM OTHER UNIVERSITIES AND TRANSFER OF CREDITS IN UNDERGRADUATE PROGRAMMES

- a) Students from other Universities can seek migration to Galgotias University, Subject to following conditions:
  - i) Migration will be allowed only in 2<sup>nd</sup> year/3<sup>rd</sup> semester
  - ii) Students must have successfully completed 1<sup>st</sup> year/1<sup>st</sup> and 2<sup>nd</sup> semesters as per the passing criteria laid down by the parent University. Student should not have any backlog.
  - iii) Students must be pursuing a regular programme in the parent University
    - (1) Having the same entry eligibility condition as the programme in which he/she is seeking migration
    - (2) Students, if he had continued in his/her parent University would have been awarded the same degree in which he/she is seeking migration
- b) Students seeking migration should be having the syllabi in the 1st year/ 1st and 2nd semester at least 75% identical to that of Galgotias University. In case of deficiencies, candidates shall have to complete the bridge/additional





course(s) as may be prescribed by the Equivalence Committee for which a fee may be charged.

- c) Student has to confirm the bridge/additional courses, from the head of the concerned department or admission department.
- d) The score obtained by the candidates in the Course of Study for the entry level qualifications as recommended by the Equivalence Committee for credit transfer shall be carried over for calculating the CGPA for successful completion of the Programme.
- e) Improvement in score of a Course Unit qualified prior to admission to Galgotias University shall not be permitted.
- f) Candidates migrating from other universities shall submit the following documents at the time of their admission:
  - i) No objection Certificate (NOC) or Migration certificate from his/her parent University.
  - ii) Authentic copy of the detailed syllabus, scheme of teaching and evaluation of the course of study pursued by him at his/her parent University.
  - iii) Attested copy of statement of Marks/Grade Card of the courses completed.
  - iv) Attested copies of testimonials relating to basic qualifications and experience etc., which were pre-requisite for admission in his parent University.
- g) The procedure for selection of candidates shall be as laid down by the Admission Committee. Reservation of the seats under this category shall be as per the provisions of Act, Statutes and Ordinances.

**2. EQUIVALENCE COMMITTEE ; IT WILL COMPRISE THE FOLLOWING**

- a) Dean of the concerned school (Senior most Dean will act as Chairperson)
- b) HOD of the concerned and allied Department
- c) Two faculty members nominated by the Vice Chancellor
- d) Registrar
- e) Controller of Examinations

The responsibilities of Equivalence Committee shall be:

- a) To determine the equivalence of a degree or other academic distinctions of other Universities.
- b) To consider and determine the eligibility of candidates seeking admission to Galgotias Universities from other Universities.



- c) To map the course units already completed by the candidates in other University/college and determine the equivalent Grade point average on a 10 point scale and credits which could be transferred for the courses completed earlier. For this purpose, absolute grading system shall be followed.
  - d) To determine the equivalence of score obtained by the candidate in a programme pursued in other University and recommend to the Examination Committee the grades on a 10 point scale for credit transfer.
  - e) To prescribe bridge courses, if any, required to be pursued and cleared by the candidates to be admitted under Migration scheme.
  - f) To recommend the candidates to the Admission Committee for admission with all the particulars of each candidate.
- 3. No migration in Post Graduate programme shall be allowed.
  - 4. No student will be migrated if he/she has a reappear in any subject of previous University from where he/she is migrated.

**Note:** Lateral Entry/Migration shall be subject to applicable adherence of guidelines issued from time to time by the UGC and other concerned statutory bodies such as the All India Council for Technical Education (AICTE), the Bar Council of India (BCI), the National Council for Teacher Education (NCTE), the Pharmacy Council of India (PCI), Indian Nursing Council (INC), Council of Architecture (COA) etc.
