1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

University has introduced the Choice Based Credit System in 2012 and further updated in 2019 under NEP. University promotes interdisciplinary approach by offering Interdisciplinary projects, honors, Minor specialization, integrated degree in engineering and management, applications and dual specializations. Each program has professional core and elective courses along with University core courses and open electives.

University has a four-step approach to design/develop/revise/amend curricula. As the initial step, the schools collect the feedback on curriculum from its stakeholders. The Program Assessment Committee (PAC) reviews the feedback collected and the curriculum is recommended to the Pre-BOS for modifications. At the second step it is checked whether the Vision, Mission, Program Outcomes, PEOs, PSOs are defined for the Programs and are in line with Vision and Mission of the University. At Third step, it is checked that the Curriculum has right blend with courses on Core Subject Knowledge, Humanities and Sciences, Ethics, and University Core Courses like Environmental Sciences, Artificial Intelligence, Waste/Disaster Management, Basic Digitization Skills, Communication and Soft Skills, Professional ethics and Human Values, Community Outreach, Digital awareness, Industry 4.0, At the final step the Pre-BOS is conducted chaired by the Dean of the School. Clarification, expertise is sought and if required industry is consulted, benchmarking is done and then final recommendations are presented in the BOS. The recommendations are presented in the Academic Council for the approval and to crosscheck the adherence to university policies.

It's being ensured that all courses, approximately 15-20 % contents based on current developments of technology and revised every year.

University has established a school specially to inculcate life-long learning skills (SLLL). The courses like communication skills, aptitude and logic building, campus to corporate, soft skills are offered to enhance the employability.

The University is instrumental in implementing curricular reforms, which has created national impact such as mandatory Six Months Industry Internship embedded in syllabi, Self-Study Course, CBCS, Credit transfer system, multidisciplinary approach, interdisciplinary approach, relative grading and University core courses like AI, Data Science, Innovation, Creativity and Entrepreneurship, Disruptive Technologies, Creative Arts, Liberal Arts, Professional Ethics, Human Values, Yoga, Meditation, Environment sciences and gender.

Teaching-learning and Evaluation

The University enjoys goodwill amongst public & society and has almost 100% admissions since inception. The admissions are done strictly on Merit basis having Demand ratio close to 10:1. University conducts its own

entrance examination since 2011. The University conducts **Right from first year Employability Assessment Test** to evaluate their communication skills, technical and aptitude level. The university identifies the slow, average and advanced learners and makes efforts to address their specific needs through various types of assessment.

100 % classrooms 136 are Smart classrooms. The university has subscribed I-authenticate from Turnitin. Various methods of experiential and participatory learning and problem-solving methodologies are adopted. The SFR of the University is less than 1:15. The university has 5 Big libraries in addition, there are departmental libraries in each school. University organizes three weeks orientation programme. Handbook containing all the information is given to students. The calendar outlines the semester commencement dates, dates of all CAT, IA parameters and End term examination, declaration of result of the examination, vacation, sports and cultural activities, schedule of progress seminars, feedback schedule, academic audit, etc. Mentor Mentee scheme is introduced from the inception of the university. Remedial teaching is a built-in provision in the teaching learning processes. Minimum one course in each semester to be learned through approved list of Swayam Courses. University has 50% weightage for Continuous Evaluation and 50% on End Term Examination. In Continuous Evaluation of 30% weightage is given to class assessment Tests (CAT) which are linked to Blooms Taxonomy Level and 20% weightage is given to Internal assessment. All departments of the University have stated its Vision, Mission which is aligned to University Vision and Mission and also defined Program Outcomes, Program Specific Outcomes (PSOs) and Course Outcomes (COs), which are integrated into the Curriculum and assessment process.

The University has examination cell which is headed by Controller of Examinations. University have ERP since long for various modules and are being used extensively for the Teaching learning, examination and from administration till issue of the transcripts. The university has Minimum CGPA 5 for Under Graduate and 6 for Post Graduate programmes.

Research, Innovations and Extension

The 'research' in the Vision statement of the University carries lot of importance to drive the research related initiatives. University has set up University Center for Research & Development (UCRD) and also various committees like Research Advisory Committee having experts from National and International domain, SRC, ethical committee, doctoral Committee, PhD coordinators, PG coordinators. The Research Mandates are developed and applicable to all. The UCRD formulates and promotes the for organizing Indexed conferences, sponsoring for registration fees and travel, research incentives for publishing papers, filing patents and safeguarding intellectual property, organizing workshops and seminars at department, school and university level on research Methodology, books writing, research paper writing, funding opportunities and National and international collaborations, lectures of Nobel laureates, sharing revenue generated, supporting Undergraduate and postgraduate projects, providing seed money etc.

University is providing financial incentives to Faculty for research outputs like paper in SCI and for Scopus, Edited Books and Book Chapters, citations, granted patent, grant. Galgotias University is providing since inception 50% wavier of Tution Fees to internal staff in the Ph.D. program. University also have defined the Plagiarism check policy. Galgotias University is amongst top 10 university/Institutes for patent filing as per report published in 19-20.

"Galgotias Incubation Centre for Research Innovation Start-up and Entrepreneurship (GIC-RISE)" is organizing various programs on Start-up Bootcamp, Startup Fellowship, Pitch Competition etc wherein e- Cell is in existence since 2016, which has been nurturing the ideas of students to make viable industry products. Course in entrepreneurship is embedded in the curriculum.

The University has signed closed to 200 MOUS with Academic and industrial organizations. The university has NSS and NCC which are established to promote regular engagement in social service to promote their holistic development and society as well. University has organized many programs for neighbourhood community like Free Health Camps, Health Education drives, role plays, street plays, Tuberculosis, AIDS, Heart Day. The Centre for Legal Aid is open to everyone for free legal aid.

GU has hosted 11 IEEE International conferences and 38 national conferences in the core areas of research. University publishes Three International Journals.

With Students First Philosophy university has well established system for students mentoring and counseling through Class Teacher, Faculty Advisor, Psychological Counselor, Dean Students Welfare, program Chair and School Dean. A well-defined structure identifies slow learners in first year and remedial teaching is carried out for them.

We provide scholarships for Merit students, Merit on admission, financially weaker students, Sports scholarships to the students. 45% students receiving financial assistance from various bodies and University. University has an International Cell to take care of PIO/NRI students. Students Council publishes newsletter 'G post'. University has a full-time sports officer.

Class representatives and Country Representatives are nominated for each year of every programme of the University. They represent the academic and other general matters pertaining to students also takes part in the meeting of QCM.

University has a well-defined mechanism for Grievance Redressal such as Grievance Cell for students, Grievance Cell for employees, Grievance Cell for Prevention for Atrocities Act (SC/ST) and ICC. There is antiragging committee, discipline committee. There is code of conduct for students and teachers which is available at the institute website and handbook.

We offer various number of capability enhancement programs including guidance for competitive examinations, career counselling, soft skill development, remedial coaching classes for weak students, and bridge courses for lateral entry students every year. Yoga and meditation is offered as part of their curriculum for their active life, students can also be benefited by higher education training.

Galgotias Alumnus are laced globally and very we connected for their alma matter. Galgotias Alumni Foundation is a registered body. Annual events of alumni are very popular amongst alumnus and they wait for awards night. There are 6 extension chapters GU alumni.

- At the Fourth step the Pre-BOS is conducted chaired by the Dean of the School. Clarification, expertise is sought and industry is consulted,
- At the final step, the program design and course curricula is ensured to meet the latest quality benchmarks and industry expectations. Final recommendations are presented in the BOS. The entire effort has been made in line with the broad guidelines of the concerned statutory bodies, make the curriculum employable, relevant to the industries nearby, relevant to local and global.

Students are encouraged to take MOOC Courses and the Credits are transferred to GU Grades.

All programs have Internship component varying from six months to one year as to develop the required skill-set as per the needs of the global practices.

It's being ensured that all courses, approximately 15% contents based on current developments of technology and state of art practices linked to BTL-6 to enhance design thinking across all programmes.

The BoS of School, chaired by the School Dean. Outcomes are assessed and attainment analytics are used to improve the academic quality, by analyzing the gap and improving the curriculum accordingly. The Programme Outcomes are displayed on the websites of the University in addition to being communicated to students through online and offline modes and also mentioned in the prospectus of the university. Programme coursebook having programme vision, mission, CO, PO, programme description, programme structure, PEOs, PSOs & Programme outcomes, assessment plan and composition of outcome.

The Courses commence with the faculty explaining the course objectives and expected outcomes to students and distribution of Course Handouts. The planned assessments, both formative and summative, are mapped to the course outcomes with appropriate degree of mapping (Strong/ Moderate/ Weak). Faculty choose the components of their continuous and term end assessments in line with the learning outcomes and the assessment rubrics are prepared to measure student performance effectively.

3.5 Consultancy

The **Galgotias University** aims to be the torch bearer of novel ideas and innovators with goal to create futuristic Research leaders. One of the important part of the Research mandate is to have extension of the research with the industries in the areas of expertise of its faculties, students and research Scholars.

Galgotias University has set up University Center for Research & Development (UCRD) to facilitate research, innovation and development of consultancy. University has developed a document namely Research Mandate. The Mandate document is updated in every two years and it regulates all research and consultancy policies, targets and also deliverable with rigorous review. The University has signed closed to 200 MoU's with Academic and Industrial organizations. Apart from that, the University has more than 300 recruiters who work closely with the university from the early career of the students. With high Industry collaboration, University could prove its potential amongst various industries for problem solving and providing training and have fetch good consultancy assignments.

University is also extending, resources, high end equipment, services of students and faculty to work on finding solutions. It also ensures to identify industrial problems in number of ways, like corporate training, internships, visit to industries and taking as case study, extending expertise of faculty and R&D facilities to the outside agencies for providing solutions. The revenue income generated out of consultancy is distributed among the concerned faculty and the supporting staff along with the share of the University as approved by the Executive Council.

The university is approaching the nearby industries through Professor In charge for Consultancy for identifying problems. Consultancy services are available in expertise areas to cater to public sector, industries, Government sector, and other national and international organization. The constancy services are offered as per the guidelines following ethical policies. Consultancy is broadly classified in **four major areas:**

- 1. Expert guidance: The university faculty can be an expert for guidance and development of projects for external agencies
- 2. Development & validation of projects: It involves the use of available university infrastructure for solving the problems related to development, testing and validation.
- 3. Resource consultancy: It includes the utilization of university resources for conducting trainings, exams etc.
- 4. Corporate Training: It includes MDPs specially for industry personals.

Every year annually portfolios at university level and school level are defined mostly on rotation basis and some internal portfolios for long duration. The formation of 30 plus committees, Deans, Associate deans, assistant deans, HoDs, Program Chair, Division Chair, Committee Coordinators Committee members, Class representatives, Placement committee, International Country Representatives. 40 students self driven clubs under Students council gives ample opportunity to stakeholders to participate and involve in the administrative acumen and smoothen academic and administrative processes. The annual report by each portfolio holder is submitted and evaluated/audited. The Deans form a core committee for academic decisions known as Programme Assessment Committee.

The Pre-BOS and Board of Studies too gives space to faculties of the University for their participation and put their views. The bottom-up approach for the syllabus revision, decision making, feedback, open house is being organized so that stakeholders feel at home. The University have the culture of active participation of faculty and students in its statutory body meetings like curriculum conclave, Academic Council and Board of Studies. The Structure of the Academic Council is formed as per act in a way that it allows faculties to put their views openly and provides equal opportunity for all.

The leadership of the University has emphasis on transparency and participation to the maximum extent at every level.

6.4 Financial Management and Resource Mobilization

6.4.1 Institutional strategies for mobilisation of funds and the optimal utilisation of resources

Response:

The availability of fund is essential for any organization, society, family or Co-operatives but the movability of fund is even more important. If the movability is in the right direction, then the level of progress is high, otherwise it becomes ineffective even though the fund is available.

- The Finance Officer and the committees of the University monitors the use of resources received from various resources like tuition fees, CSR funds, Consultancy and Non-Government funds.
- The allocated funds are utilized to purchase equipments, chemicals, organize seminars, workshops and conferences etc.
- The administration and finance committee and the management board, review the use of resources including audit, budgets and accounts. They make recommendation for better handling of resources and effective mobilization of available funds.
- For the smooth working of our University various committees have been constituted, each committee study its own field and analysis to requirements and then forwards it's to analysis committee with expected expenditure and planning.
- Planning and analysis committee look over these requirements minutely and then adding the future aspects and planning, forward it to finance committee for clear opinion.
- Finance committee goes through minutely all the suggestion and analysis and then act accordingly for the betterment of students, professors, non-teaching staff, then report is finally handed to management committee.
- No institution is recognized by its infrastructure but by the success of students studying in it. Therefore 10% of the income is invested on purchase of books and apparatus, sports, youth festival and some other programs.
- Salary of teaching and nonteaching is contributing to the extent of 45% of the income is spent on

their salary and up-gradation.

- Cash flow management is done and scientific budgeting process is adopted.
- Faculty members are encouraged to organize breakeven point or zero budget.
- A healthy mind resides in a healthy body, for these various programs like sports, yoga, personality development and other activities are organized and the finance committee spent 5% of the income on this.
- University is spending 10% budget on research (To upgrade the students, professors and employees' various programs such as guest lectures, seminars, discussions are organized. Not only this, they are encouraged to participate in different institution, research work, Incentives are declared defined 0.05 percent of the income is defined.) and 5% on advertisement and promotions. In this way students proceeds towards their bright future by gaining knowledge and their overall development. For the effecting teaching and learning, it is very important that the environment and campus of the institution should be clean and attractive.
- GU is known or one of the green and clean campuses and 20 percent fund is allocate for maintenance (Electricity, water, internet, website and telephone bills).
- In this way 10% of the fund is kept safe for miscellaneous expenses and for certain emergency situation.
- At the same time the allotted fund is reallocated in case Un-Utilized OR required. In this way through effective financial management the University is attaining new heights and achieving its goal. Faculty members are encouraged to apply for funds/grants.

6.4.4 Institution conducts internal and external financial audits regularly

Response:

The University has set-up an integral mechanism for conducting Internal Audit on the financial transactions and operational procedures every year to ensure compliances under various statues and principles. A reputed firm of Chartered Accountants has been appointed by the finance committee to perform internal audit on day-to-day basis.

The **Internal Audit** Team methodically verifies the income and expenditure details and compliance of the standard operating procedures set by those charged with governance. The compliance report of internal audit is submitted to the management of the University through Vice Chancellor.

The **External Audit** of the university is being conducted once every year by a designated external agency.

Before the commencement of every financial year, bottom-up approach is adopted. All School Deans submit the budget to Dean Planning & Dean Planning consolidates the budget and puts up to the Vice Chancellor who further recommends the budget allocation to the Financial Committee of the University.

The budget includes recurring expenses such as employee's Salary, Electricity, Internet charges, Maintenance cost, Stationery, Other consumable charges etc., and Fixed heads like Lab Equipments, Furniture & Fixtures, Research Development, Faculty Development, ERP, Examination Budget, Books, Journals etc. The expenses are controlled and monitored by the accounts department as per the budget allocated against each expenditure head by the University. The depreciation cost of various types of equipment's/items acquired and purchased in the preceding years are also worked out as per the accounting procedures.

The financial power is given to various posts accordingly they appear and exercise the matters.

ERP has been implemented to monitor the Financial Expenses and Utilization. Purchase Department and store have their own SoPs in place, The physical verification is carried out every year.

Process of the Internal audit:

All Transactions Vouchers are being audited by an internal audit team of the University on daily basis. The expenditure incurred under different heads of expenses is being thoroughly checked by verifying the expenditure invoices and its relevant vouchers. If any discrepancy or incongruity is found, the same is brought to the notice of the University Finance Officer.

Process of the external audit:

The Accounts of the University are audited by the designated Chartered Accountant duly following all the rules & regulations of the relevant statues.

The University auditor ensures that all payments and expenditures incurred are duly authorized and after the Audit, the Audit Report is sent to the University Management for its review. Any query or issues that arise, in the process of the audit would be attended immediately along with the supporting relevant vouchers and documents within the prescribed time limits.

All these mechanisms in place, exhibit that full transparency is being maintained in financial matters and full adherence to financial discipline to avoid any defalcation of funds, properties, and recourses of the University at any level.

The audited statement of University Accounts is being duly signed by the authorities of the management of the University and approved by EC every year.

- The University is well equipped with the proper security personal along with lady guard and CCTV cameras are installed in the university premises and hostels.
- The University organizes various programs such as seminars to keep the girls updated about their rights and security. They are encouraged to approach the women empowerment and women grievance cell for any of their inconveniences.
- The University has an Internal Complain Committee (ICC) for handling the cases of sexual harassment.
- The self-defence course is organized by the Students Council for girl's students
- Women Empowerment and welfare committee is very active in the campus and ensures healthy environment is maintained in the campus
- A lady gynaecologist has been appointed at the medical centre.
- It's been ensured that that every class has two representatives one girl and one boy to understand their difficulties.

Counselling:

- The University follows mentor-mentee system to counsel the students, each mentor is assigned with 10-15 students. It is being preferred that female faculties are assigned to female students.
- Students are given equal opportunities to participate in various activities such as cultural programs, and seminars to treat the opposite gender equally and respectfully.
- International women's day is celebrated by all to ensure and celebrate the gender equality and value women.
- In NCC, NSS and Student council, equal opportunities are given to male and female candidates.
- Galgotias University also has a separate girls NCC wing having more than 200 students enrolled and won several awards led by the woman instructor.
- University has dedicated Psychological Counselling centre headed by Dr Shikha Srivastava who organizes various programs and also available round the clock for students' difficulties
- The Dean Students welfare's office ensures that every request/ complaint is attended at no time.

Common room:

• The university has a separate common room for girl students. Women staff and faculty are provided separate cabins. Each floor of each block has separate toilet for female faculties equipped with

Sanitary disposal machines and Vending machines.

Day Care centre for the Children of the Staff: The University has beautiful centre for Day Care.

Any other point: University has given equal opportunities to women candidates in the University Governance. The decision makers and administrators in the university are women at many places. Beginning with the Vice Chancellor, Director-HR, Director-CPDD and Deans of several schools, all these responsibilities are being handled by women. University has a separate women empowerment cell which organizes various women empowerment programs. University HR policy includes maternity leave and child care leave to the women faculty and staff members. Every year, Chancellor's trophy (which is the highest honour) given to one of the outgoing deserving girl students. It's being ensured that every committee of students/ teachers have women representation.

The Context:

At Galgotias university, student council was first formed in 2012. Since then, it has been consistently working for the welfare and interest of its students. Galgotias university student council is a conglomerate of student's clubs and societies at the university. The council is a part of the University administrative and academic structure unlike an independent Union. The council is devoted to the educational interests and welfare of its members while following strict guidelines established by the University.

Mission:

Holistic development is what we aim for by providing representation, educational development and social and extracurricular opportunities.

Vision:

At the heart of the student experience, we strive to have a positive impact on each and every one our members.

Values:

- **-Trust**: we put faith and trust in our students and their ability to manage student activities as well as inspiring trust in our students while being open and honest with them about their student council.
- -Integrity: We aim to create an inviting atmosphere for all of our students to become involved in the local and national student community and the residential community of the city they dwell in.
- **-Environment:** we look not only to campaign about issues surrounding our environment but provide an example for others to follow by reducing our carbon footprints and constantly improving our methods of recycling. We also believe in providing safe and friendly spaces for our students use.
- -Equality: We encourage a culture of friendship between all of our students regardless of sex age race

-Empowerment: The opinions fears, prospects and wishes of our students are at the heart of everything we do allow us to set targets that are realistic to their expectation.

Constitution:

Establishment and Name:

- 1. There shall be only one student council at the university.
- 2. The name of the student council shall be 'Galgotias University council'.

Declaration: The Student Council does not act independently under any circumstances; any new agenda is presented to the university administration in form of the written report and is not acted upon unless approved. Other than their cardinal role the student executive officers that forms the core team that are responsible for all forms contacts between the student members and university administration (the Vice chancellor, pro-vice chancellor, The proctor, Dean Academics and respective school deans) and are required to inform the authorities before conducting any activities on the campus.

Membership: Any student who enrolls at Galgotias university is automatically registered as the general member of the student council upon registering upon one of our clubs become full time, giving them access to all of our services and to an organization which is able to represent them to the communality and the world beyond. They are also given the right and the power to shape the councils' directions through member feedback and annual meeting.

If for any reason a member does not wish to be a member of a council, they can opt out of the membership any time by emailing the council HR for the council core team. A student can still enjoy all of our facilities, but they cannot have a voice at membership meetings or other democratic activities.

Council Core Team: There shall be a representative body that runs the day to day activates of the clubs and the societies. This representative body that forms the core of the council stay in direct administrative contact with the university management for the introspection and successful executions for the students activates. Council core shall consist of appointed council executives. A council meeting can be called by any of the university administration, The executives, Two Third of council members. At least one working day should be given for all council meeting except I it is called by university administration. Motion or discussion must be submitted to general secretary two working days prior to the conduct of meeting. Quorum for the meeting shall be 60% of the registered students.

The Executive: The executive body shall be responsible for the initiation of policies, general meetings and any decision. The executive (core) shall consist of the following posts:

- 1. General Secretary (chief administrative officer and principal spokesperson)
- 2. Chief Secretary (Chief operation officers)
- 3. Joint Secretary
- 4. Vice Secretary
- 5. Regent Secretary

6. Deputy regent secretary (Head of Events)

Only final year students of their respective courses shall be appointed as core executives. No member of executive course may hold any other position in the council.

The Practice: Student Clubs/Societies:

At the University, Students Council, encourage the students to become a member of different clubs and committees. With around 40 plus different clubs, University connects students to a platform where they can exchange knowledge, build awareness, and receive recognition. The clubs/committees, also provides students with an appropriate platform to showcase their talent. Through active participation in various activities, students develop leadership qualities, team spirit, time management, critical thinking and life skills as well. Galgotias University Student Council works to inculcate following traits among the students:

- Encourage the students to take leadership roles and responsibilities by appointing them on various responsible posts in the student Council.
- Provide them with the congenial environment where they can air their ideas.
- Foster a sense of belongingness among the students by promoting and keeping the rules and regulations of the university. The students are encouraged to become a member of different clubs and committees. With over 40 different clubs, Galgotias University connects students to a platform where they can exchange knowledge, build awareness, and receive recognition.

Problems Encountered and Resources required:

The student council members of the university have to spend lot of personal and day time for coordination, organisation and management of the activities.

Resources required: Management's support a significant aspect in enhancement of effectiveness and smooth functioning of a student council. Galgotias university has provided all financial, disciplinary, technical, and well-furnished office to the Students Council.

Best Practices 2: Outcome Based Education

Objectives of the Practice:

OBE is a flexible, empowerment-oriented approach to learning Outcome-based education is a model of education that rejects the traditional focus on what the school provides to students, in favor of making students demonstrate that they "know and are able to do" whatever the required outcomes are.

The Context:

The Galgotias University is one amongst few Universities of India who have implemented Outcome Based Education since its inception. All departments of the University (technical and Nontechnical) have stated its Vision, Mission which is aligned to University Vision and Mission and also defined Program Outcomes, Program Specific Outcomes (PSOs) and Course Outcomes (COs), which are integrated into the Curriculum and assessment process. The learning outcomes are clearly defined using blooms taxonomy for all academic programmes. All courses of the program are mapped with the POs and PSOs along with their level of correlation: 1 (low), 2(medium) and 3 (high).

It is ensured that all POs/PSOs are adequately covered by the courses being taught and each course is mapped to highly correlation level with at least one PO. It also ensured that all POs/PSOs have high correlation with adequate number of courses. Feedback from Students, Parents, Recruiters, Industry, and Alumni are taken for indirect assessment. The Courses commence with the faculty explaining the course objectives and expected outcomes to students and distribution of Course Handouts.

All the faculties of the University have undergone the OBE training of 2 weeks/ have done NPTEL course or certified OBE teachers. University conducts special training every year for updating the faculties with the new processes adopted in the OBE.

The Programme Outcomes are displayed on the websites of the University in addition to being communicated to students through online and offline modes and also mentioned in the prospectus of the university. Programme coursebook having programme vision, mission, CO, PO, programme description, programme structure, PEOs, PSOs & Programme outcomes, assessment plan and composition of outcome.

The faculty prepares their session plans by incorporating appropriate pedagogies, Blooms Level and learning outcomes suitable to achieve the Course Outcomes. The LMS/ ERP is used for Internal evaluations including MCQs, projects, roles play, presentations, internships, research-based assignments, dissertations, vivas, open book tests, critical thinking seminars, lab work, simulations, service-learning components and other co- curricular activities ensure that the assessment is always linked to COs. One of the Internal assessment tests CAT3 is only on assessing the design/innovation quotient of the student and BT level 6.

A special software INPODS (QBMS) has been adopted for designing the questions which are linked to Cos and BT level. It assesses the level of attainment through CO assessment and the gap analysis is done by the PAC committee. The Inpods module of QBMS helps the faculties to design CO based question paper mapping to BTL. The attainment of the outcomes, both at programme and course level, is computed by aggregating the marks obtained by students in all the assessments conducted as a part of course evaluations. These include both formative (continuous) assessments and summative (semester end) evaluations. Assessments at Galgotias university include Internal Assessment (IAs), Continuous Assessment Tests (CATs) and End Term Examination (ETE). Assessments conducted are mapped (question-wise or CO-Wise and Bloom Taxonomy Level Wise) with appropriate degrees of mapping. All the evaluations conducted at the course level for a particular course outcome are aggregated

Evidence of Success

The attainment of the outcomes, both at programme and course level, is computed by aggregating the marks obtained by students in all the assessments conducted as a part of course evaluations. These include both formative (continuous) assessments and summative (semester end) evaluations. Assessments at Galgotias university include Internal Assessment (IAs), Continuous Assessment Tests (CATs) and End Term Examination (ETE). Assessments conducted are mapped (question-wise or CO-Wise and Bloom Taxonomy Level Wise) with appropriate degrees of mapping. The attainment of COs is compared with the target level. The CO is said to be attained if its attainment value is greater than or equal to target attainment level. The PSOs attainment is calculated by the process similar to that used for POs attainment.

Total Attainment = Direct Attainment * 0.8 + Indirect Attainment * 0.2

Outcomes are assessed and attainment analytics are used to improve the academic quality, by analyzing the gap and improving the curriculum accordingly. Based on the results of implementation of outcome assessment, gaps in the desired target and the results actually achieved for each programme are identified. In the outcome assessment implementation report, schools also propose the action plan to address these gaps which serves as an input during the programme review and strategic planning of the university.

The graduates who are produced through the process their employability is very high and visible.
