

MEMORANDUM OF UNDERSTANDING

AGREEMENT FOR AN ACADEMIC COOPERATION AND STUDENT EXCHANGE

Recognizing the mutual benefits to be gained through this partnership promoting scholarly activities and international understanding.

SRH Hochschulen GmbH, the operating company of SRH Universities of Applied Sciences Heidelberg, based in Ludwig-Guttman-Str. 6, 69123 Heidelberg, Germany - represented by the Managing Director, Dr. Thorsten Bagschik

and

GALGOTIAS University, Noida, India - represented by the Dr. Dhruv Galgotia, CEO

enter into this agreement and do hereby affirm their intention to develop academic exchange and cooperation in education and research between both institutions and furthermore agree as follows:

1. Purpose

In order to facilitate academic cooperation and promote mutual understanding, both partners agree to explore the feasibility of establishing a framework for educational and scientific cooperation. The two institutions shall seek to promote programmes in the following areas:

- (1) Joint short-term courses and summer schools for undergraduate and graduate students
- (2) Joint research and development projects
- (3) Student information on postgraduate study programmes at both institutions
- (4) Staff exchange programme
- (5) Student exchange programme

Exchange of students will occur on a one for one basis. This number may vary in any

given year, but over a fixed period of three years, the total number of students participating should balance. According to the aforementioned rule, tuition fees will be waived at home institution.

(6) Other forms of co-operation which the two institutions may jointly arrange.

2. Further agreements

Themes of joint activities, the conditions for utilizing the results achieved, arrangements for specific visits, exchanges and other forms of cooperation will be developed mutually for each specific case. Any commitment of resources, financial or otherwise, must be made in specific agreements to be entered into for this purpose at a subsequent date.

3. Legal character

This document is not intended to create binding or legal obligations on either party. Supplemental, specific agreements may be necessary to set out in detail the responsibilities of each party in respect of (1) selection and enrolment requirements (2) accommodation and other services for students (3) any other terms and conditions necessary for the achievement of the proposal. The parties acknowledge that all or any financial arrangements proposed must be negotiated and will depend upon the availability of funds.

4. General provisions

This agreement shall commence on the date of signing by both parties and remain in force for a period of five years. It may be terminated by either party giving the other party six months' notice in writing. Termination of the agreement will not affect participating students from either institution exchange so that they may complete the agreed-upon duration of their participation. This Memorandum of Understanding may be amended or extended at any time by mutual consent through an exchange of correspondence between the two institutions. The parties agree to consult periodically concerning the status of these explorations and other relevant matters.


