The university identifies the learning levels of the students through specialized tests like AMCAT that are based on assessing the communication skills, technical and aptitude levels of the students. The university also conducts Employability Assessment Test in the first year of studies of the students for early identification of learning levels of the students as Slow, Average, and Advanced learners.

Special programs are then arranged to provide appropriate support to

the students as per their learning levels and improvements are monitored on regular basis. Learning Level of students are mapped to the Bloom's Taxonomy level and Course Outcomes at the end of each semester. The Continuous Assessment is activity based and class tests have been mapped to learning levels.

The university invests extensive efforts to address the specific needs through various types of supporting programs, counselling, mentorship sessions, specialized learning programs, and assessments. Various methods of experiential and participatory learning and problem-solving methodologies are adopted to improve the learning levels of students.

Special cares are taken to motivate the Advanced learners to keep performance levels high, Average Learners to Excel, and slow learners to be mentored and monitored to bring them to next level.

The classroom teaching in the University is supplemented with the use of ICT Tools including Smart Boards, Internet Resources, Interactive Presentations, Video Sessions with Lecture Capturing System, and Simulation recourse etc. Teachers make use of innovative ICT-based teaching content and tool including virtual labs (in collaboration with IIT Delhi) and technical simulators.

The various tools available with the department which students use for their laboratory session or project work are Creo, AutoCAD, ANSYS (Mechanical), STAAD Pro (Civil), MATLAB, LabView, Power world simulator, PSCADA. Scilab, CATIA, Tableau, Adobe, SPSS, Programming, Python and many more.

Online resources like eBooks, eLabs, Digital Libraries, eJournals, Academic Databases, MOOCs and Blended MOOCs (Coursera, EDX, etc.) are rigorously used in teaching and learning processes.

Learning Management System based on MOODLE has been implemented for effective use of ICT enabled teaching and learning resources of the University. MOODLE at the Galgotias university has been developed as a revolutionary learning asset to cater end-to-end learning requirements on Outcome Based Education (OBE) including Interactive Learning, Assignments, Assessment, and Feedback.
