Against the recognition order of the Northern Regional Committee, the institution preferred an appeal before the NCTE (HQ) under section 18 of the NCTE Act, 1993, The Appellate Authority remanded the matter back to **Northern Regional Committee** for processing for grant of additional course of ITEP.

5. AND WHEREAS, the matter of the TEI/HEI was further considered by the Regional Committee on **03/03/2026 in Meeting No. 460th Meeting held on 03.03.2026**.

10. The institution shall submit to the Regional Committee a Performance-Appraisal Report (PAR) at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

11. The institution shall maintain its own website with hyperlink to the NCTE website uploading the required information / documents as per clause 7(14) of the NCTE Regulations 2014 as amended time to time.

12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to date information on its official website.

13. If the Institution Contravenes any of the provisions of the NCTE Act, Rules, Regulations, and orders made or issued thereunder, the action including withdrawal of recognition shall be taken by the Regional Committee concerned under the provisions of Section 17(1) of the NCTE act 1993.
