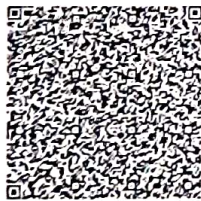

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding "MOU" is signed on 23rd day of November month of 2022 year.

By & Between

Dr. Bakshi's Healthcare Private Limited, having its registered office at 210 Padma Tower-II, 22 Rajendra Place, New Delhi -110008, (hereinafter referred to as "**DBH**") represented by its Authorized Signatory, Ms. Sudha Chakrapani, which expression shall unless repugnant to the subject or context mean and include its successors and assignees of the FIRST PART.

And

Department of Psychology, Galgotias University, having its registered campus at Plot No. 2, Sector 17-A, Yamuna Expressway, Dist. Gautam Buddh Nagar, UP – 201308. (hereinafter referred to as "**DOP**") represented by its Authorized Signatory, Mr. Nitin Gaur, Dean, Registrar, Galgotias University, which expression shall unless repugnant to the subject or context mean and its assignees of the SECOND PART.

DBH and DOP shall hereinafter collectively be referred to as the "Parties" and individually the "Party" and interchangeably.

WHEREAS,

1. DBH is engaged in the business of providing mental wellness, comprehensive programmes and customized interventions for chronic lifestyle disorders and emotional wellbeing.
2. Department of Psychology (DOP) is a part of School of Liberal Education under Galgotias University in Greater Noida.
3. DBH has represented that it has expertise in providing psychological training and conducting programmes and clinical research to the students of DOP.

IN CONSIDERATION OF THE MUTUAL BENEFITS, AGREEMENTS, COVENANTS AND PROMISES HEREIN, AND OTHER GOOD AND VALUABLE CONSIDERATION, THE SUFFICIENCY OF WHICH IS HEREBY ACKNOWLEDGED, THE PARTIES HERETO HEREBY AGREE AS FOLLOWS:

I. PURPOSE OF MOU/ SCOPE

- a) This MOU is signed with the noble vision of imparting requisite knowledge and skills to the student pursuing Bachelors and Masters in psychology for bridging the gap between industry & academia and thereby enhance their employability.
- b) To promote interaction between DBH and DOP in mutually beneficial areas of upcoming skill & technologies, identified and consented by both Parties to increase the internship

and employment opportunities for students of DOP.

- c) DOP shall provide DBH with the number of students to be mutually agreed upon for the days and hours as per the Agreement which will be informed prior to their posting for Internship.
- d) DBH shall provide internship programmes along with compulsory paid training programmes to the psychology students (Bachelor and Master) of DOP to bring out the practical application of their area of expertise. The free internship shall be available to the students clubbed along with the mandatory paid training programme introduced by us.
- e) DBH shall issue separate certificates to students for internship and training programmes.
- f) DBH may allow the students enrolled in the internship programme to collect data for the purpose of clinical research but only with the prior consent of the client(s).

2. DURATION OF INTERNSHIP & TRAINING PROGRAMMES

Internship programmes clubbed along with compulsory paid training programmes shall be available for the following durations - 30 hours, 60 hours, etc. Minimum duration would be 30 (thirty) hours and shall be extendable on mutually acceptable terms subject to interval of 30 hours.

3. TERM OF MOU

The MOU shall become effective from date of signing of MOU and shall remain valid for a period of 1 (One) year unless terminated or modified as herein provided by mutual consent of the Parties in writing. Either Party may terminate this MOU, giving the other 30 (thirty) days written notice.

4. CONFIDENTIALITY

- a) All information which has been disclosed to or obtained by either Party at any time during the implementation of this MOU, is confidential information which is not to be disclosed to any third Party without prior other Party consent.
- b) In connection with the performance of this MOU, the Parties hereby agree,
 - i. to keep the information pertaining to the client/case confidential
 - ii. not to use or disclose the confidential information for any purpose, DOP can disclose the Confidential Information only after having obtained the prior written consent from DBH.
- c) Compelled Disclosure: If the DOP or its affiliates are legally compelled (including without limitation, by law, rule, regulation, or governmental relating or administrative

or similar agency), DOP shall provide a prior written notice to DBH and shall duly comply with all the duties and responsibility as stipulated in clause 6.

5. NOTICE

Any notice or communication required or permitted under this MOU shall be sufficiently given if delivered in person or by certified mail, return receipt requested, to the registered address set forth in title above.

6. GENERAL TERMS AND CONDITIONS

- a) DOP accepts that any disclosure of Confidential Information, publish, advertise from it or from any of the students affiliated to DOP, shall be the sole responsibility of DOP and it shall indemnify DBH against any loss or damage.
- b) DOP accepts that the DBH shall not be bound by any declaration or undertaking given by the DOP to any authority(ies) on its own account.
- c) DOP has confirmed that the DBH has already informed about its paid training programmes and internships and DOP agrees to take all possible steps to ensure the confidentiality and protect against any violations in regard to any of terms set forth in this MOU.
- d) It is mandatory for all the students to register themselves in paid training programmes to avail free internships from DBH.
- e) The Parties, their representatives, and/or assignees, following the execution of this MOU, desire to maintain close contacts with each other to achieve the goals and objectives of, and to develop the ideas acknowledged in this MOU.
- f) Both Parties hereby agree to designate a representative from its side who will be the primary point of contact on behalf of that Party.
- g) Both Parties agree to take all reasonable steps to ensure the successful completion of the collaboration and co-operate with each other in duly carrying out the obligation agreed upon.
- h) The Parties hereby agree that they are not bound exclusively by this MOU and are at liberty to enter into any separate agreements or arrangements with any third party without reference to the other Party.

7. GOVERNING LAW AND JURISDICTION

This MOU shall be governed by and construed in accordance with the laws of India, without

giving effect to any choice of law and or conflict of law provision. The Parties consent to be under exclusive jurisdiction of the courts of New Delhi. Each Party shall bear the cost of their respective Advocates and Solicitors.

8. DISPUTE RESOLUTION

All or any disputes arising out or touching upon or in relation to the terms and conditions of this MOU, including the interpretations and validity of the terms thereof and respective rights and obligations of the Parties, shall be settled amicably by mutual discussion, failing which the same shall be settled through Arbitration and Conciliation Act, 1996 as may be amended from time to time.

The Place of Arbitration shall be New Delhi.

This MOU is executed in two counterparts, each of which shall be deemed original, but shall together constitute one document only.
