

MEMORANDUM OF UNDERSTANDING

BETWEEN

GALGOTIAS UNIVERSITY AND LENSKART.COM PVT LTD

I. INTRODUCTION

This binding MEMORANDUM OF UNDERSTANDING ("MOU"), is dated 14th September 2023 executed at New Delhi, between Galgotias University "Lenskart.com" An organization established under the laws of India with its registered office at GALGOTIAS UNIVERSITY. Plot No.2, Sector 17-A Yamuna Expressway, Greater Noida, Gautam Buddh Nagar, Uttar Pradesh, India represented by Ms. Manisha Chaudhry (Director CPDD) and Lenskart.com Pyt Ltd having its registered office at W-123, Greater kailash-II, New Delhi 110048 represented by Sumit Marda (CEO) collectively referred to as the "Parties" and individually as a "Party".

II. PREAMBLE

WHEREAS, the Partner, is an organization established with the goal of providing education in the field of optometry.

WHEREAS, Lenskart.com Pvt Ltd is a private company formed under the laws of India for undertaking activities in the field of vision correction, conducting eye checkups and spreading awareness about the importance of improving eye health.

WHEREAS, this Memorandum has as its objective the collaboration and participation of both organizations for the purposes of

- 1)Quarterly engagement program for the optometry students
- 2) providing learning platform on retail Optometry, through an internship program for final year optometry students
- 3) Job placement in Lenskart.com Pvt Ltd through a campus drive for internship students. THEREFORE, the Parties wish to continue working together and in compliance with the following clauses set forth below:
 - A. Optometrist Internship
 - B. Campus drive

III. GOAL

The Parties have agreed to work together towards

1) To provide exposure on Retail Optometry through various engagement programs & Internship program which will help to improve the Dispensing standards of Indian optometry

2) To provide job placement for the students and to fill in the requirement of Optometrists in India which will help in reducing preventable blindness in India.

The Parties agree and acknowledge to collaborate on the following areas:

1) Optometrist Internship program

- Lenskart will be providing a learning platform for Internship students on retail optometry
- They can do internship at Lenskart stores for 3 months, 6 months, 9 months or 12 months as per their interest.
- They will be posted in Lenskart stores for the selected tenure and will be trained on various retail topics via observation.
- A dedicated trainer will be giving in-store training to the posted interns.
- Lenskart will provide support in learning during the agreed tenure. Accommodation, travel, food and other expenses would be worn by the interns.
- The Lenskart is not responsible for any fees which are collected from students by the college for the internship program which is provided by Lenskart to interns
- The selection of students will be done by the Lenskart academic team by examination or by interview on merit basis only based on the no:of available seats.
- An 8 hour shift for 6 days/week will be assigned for the Intern during the internship period.
- Lenskart grooming standards to be maintained throughout the program
- Students will be monitored on their daily learnings and attendance as a part of internship
- Any activity of the interns which affect adverse to the good reputation of the Lenskart will be terminated without any notice
- Certification will be done on the last day of the program on successful completion of the internship without any breach.
- Lenskart will not be responsible for any other academic related matters by the students.

2) Campus drive

- Lenskart will conduct campus drive for students who are about to complete the course/completed the course and results awaited.
- Colleges to organize the program at campus premises, Lenskart team of maximum 5 people will be conducting the campus drive for the students.
- Based on the no: of students campus drive can be held in a day or two.
- Selected students will join once their course period is completed through the process.

IV. RESPONSIBILITIES AND OBLIGATIONS OF PARTNER

The Partner is responsible for undertaking and ensuring the following:

The Galgotias University should arrange the platform for the engagement program, selection of Interns and for the campus drive.

V. REPRESENTATIONS & WARRANTIES OF THE PARTNER

- d. It holds valid licenses, registrations and approvals necessary for the purposes of the activities contemplated in this Memorandum.
- e. It has undertaken similar activities and projects as contemplated in this Memorandum and has the necessary expertise, resources and personnel to deliver the agreed goals/milestones.
- f. There is no legal proceeding or litigation pending or threatened against the Partner.
- g. The Partner is an educational organization of good standing and is not on any warning list or defaulter list of any of the government authorities.

VI. DUE DILIGENCE

Lenskart may request copies of documents on the registration, university collaboration etc., if it meets appropriate standards of capacity, competence, and financial accountability. These documents include but are not limited to the following: a certificate of incorporation, a list of projects undertaken by it, a list of the names of all of its board members and principal officers, tax registrations, foreign donations, FDI status, copies of Partner's bylaws and articles of incorporation. The Partner agrees to notify Lenskart immediately of any change in its status or operations, or if any official judicial, legislative, or administrative proceeding is instituted against it. Such due diligence shall not absolve the Partner of its obligations under this Memorandum.

The Parties agree that any intellectual property, which is created or developed through activities and arrangements pertaining to the center specified under this Memorandum, shall be exclusively owned by Lenskart and used for non-profit, and non-commercial purposes after prior written consent of Lenskart.

The Partner also agrees and acknowledges that the Partner shall not issue any press releases or otherwise make any public statements with respect to the arrangement contemplated herein without the prior consent of Lenskart.

IX. EFFECTIVE DATES AND AMENDMENTS

This Memorandum shall take effect upon signing by both Parties and shall remain in effect for a period of 1 year from that date unless earlier terminated.

Neither Party may assign or transfer all or any portion of this Memorandum without the prior written consent of the other Party.

The Memorandum may be renewed at the end of this period by mutual written agreement by both Parties.

The provisions of this Memorandum may only be amended or waived by mutual written agreement by both Parties.

Lenskart may terminate this Memorandum (and any related agreement, work plan and budget, if executed/agreed) at any time and for any reason by giving thirty (30) days prior written notice to the Partner.

X. TRANSFER OF FUNDS

The Parties acknowledge and agree that this Memorandum does not create any financial or funding obligation on either Party, and that such obligations shall arise only upon joint execution of a subsequent agreement or work plan (if entered between the Parties) that specifically defines the terms and nature of such obligations and that references this Memorandum. Such subsequent agreements or work plans, and budgets, will be subject to funding being specifically available for the purposes outlined therein.

XI. NO JOINT VENTURE

Notwithstanding the terms "Partners" herein, the Parties agree that they are not entering into a legal partnership, joint venture or other such business arrangement, nor is the purpose of the Parties to enter into a commercial undertaking for monetary gain. Neither of the Parties will refer to or treat the arrangements under this Memorandum as a legal partnership or take any action inconsistent with such intention.

XII. GOVERNING LAWS AND JURISDICTION

This Memorandum shall be governed by Indian laws. [Al] the issues and disputes arising out of this Memorandum shall be subject to the non-exclusive jurisdiction of the courts in New Delhi.

XIII. INDEMNITY

The Partner agrees to indemnify and hold harmless Lenskart from and against any and all claims, lawsuits, actions, damages, loss, costs and expenses (including attorneys' fees), and demands, by third parties, that in any manner result from the Partner's breach of obligations and undertakings in this Memorandum or its omission or negligence or willful misconduct or default. Lenskart.com Pvt Ltd liability under or arising out of this Memorandum shall be restricted to the last invoice payable by it.

XIV. ENTIRETY

This Memorandum including all Annexes, embodies the entire and complete understanding and agreement between the Parties and supersedes all prior agreements, documents and correspondences executed by the Parties.
